<b>ITEM 1</b>	<b>TO DISCUSS THE ISSUE OF SHRI DULAL BARMAN, PHYSICAL INSTRUCTOR, OFFICE OF THE DISTRICT SPORTS OFFICER, SIVASAGAR, A CANDIDATE REGISTERED FOR THE POST GRADUATE DIPLOMA IN SPORTS COACHING 2021 IN VIEW OF THE FINAL EXAMINATION SCHEDULED TO BE HELD FROM 11/12/2021.</b>
<b>Decision</b>	<p>After extensive discussions, the committee placed certain points regarding the provisional candidature of Shri Dulal Barman, who is an In service Candidate working as a Physical Instructor in the Office of District Sports Officer, Sivasagar:</p> <ol style="list-style-type: none"> <li>Shri Dulal Barman, has been given provisional admission to the Post Graduate Diploma in Sports Coaching Program (PGDSC) 2021 Programme (a full time two semester program) due to his non submission of NOC. At the time of admission, he submitted an application to the Registrar of the University on 18/01/2021 stating that he would submit his NOC within three weeks from the date of application. However, he failed to do so.</li> <li>Even before appearing in the first semester examination Post Graduate Diploma in Sports Coaching, he failed to submit the NOC.</li> <li>The second semester classes of the PGDSC programme started from 2<sup>nd</sup> August, 2021 in online mode due to Covid-19 complications and from 6<sup>th</sup> September, 2021 classes were resumed in offline mode but Mr. Dulal Barman failed to report at the university for the classes for which a letter vide no. SASU/CHB/SC/MISC/01/2021/03 dated 06/09/21 was issued to him to the state the cause of his absence in which he failed to respond till date. In pursuance of the letter number stated above another two notices vide no. SASU/CHB/60/2020/379 and SASU/CHB/60/2020/399 dated 1<sup>st</sup> Nov. 2021 and 11<sup>th</sup> Nov. 2021 was issued in favour of Mr. Dulal Barman to state the cause of absence and status of submission of NOC. But Mr. Dulal Barman has not yet responded till date by any means of communication.</li> <li>In view of the above, a Standing Committee meeting of the University was held on 01/12/2021 and as per decision of the meeting, a final notice was issued from the Registrar regarding submission of NOC from the concerned department on or before 07/12/2021 . In spite of several notices, he did not respond resulting into gross misconduct and negligence on the part of the candidate.</li> </ol>




As per article no. 2.08.02 of Academic regulation of the University, the attendance of Mr. Dulal Barman does not meet the required minimum attendance for appearing in the end term examination as certified by the concerned faculty member teaching different courses in the PGDSC Programme.</p> <p>In view of the above mentioned points, the members of the Academic and Activity Council of the University unanimously came to a decision that the provisional candidature of Shri Dulal Barman for the PGDSC Programme stands cancelled.</p>
