NOTIFICATION

Sri SriAniruddhadeva Sports University is the first Sports University of Assam established by the State Government in the city of Chabua, Dibrugarh. It was established by the Act of Assam Legislative Assembly (No. LGL.164/2018/7). The University came into force on 22nd June 2020 from the date of joining of the first Vice Chancellor Prof. J.P.Verma and has been approved by the UGC under the 2(f) category.

Further, the Sports & Youth Welfare Department, Government of Assam with the assent of the Hon'ble Chancellor, Sri SriAniruddhadeva Sports University notified the First Statutes of the University to vide Letter No. SYW 73/2021/267 dated 7th October2021. As per Clause 33 of the Statute, the Court shall be the apex body of the University and have the following powers and functions:

- a) To review from time to time, the broad policies and programs of the University and to suggest measures for the improvement and development of the University.
- b) To consider and pass resolutions on the annual report, audit reports, the annual accounts of the University, and statement of financial estimates for the succeeding year.
- c) To advise the State Government in respect of any matter which may be referred to it for
- d) To perform such other functions as may be prescribed by the Act, Statutes etc.

As per the Clause 33(e) of the Statutes of Sri SriAniruddhadeva Sports University, the Court is constituted with the following members who shall hold office for a period of three years except for the Chancellor:
